II. WVTSC PRESENTATION:

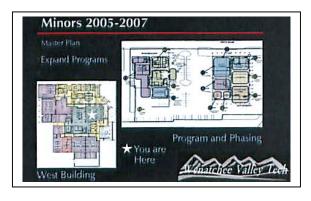
WVTSC Director, Jon Torrence, Project Manager John Hultman and Architect Paul Cappock presented the following to the board.

Discussion about as state cuts continue the existing centers will get priority over new or branch centers in the state.

Board discussion continued about the potential and possibilities for WVTSC. They talked about a feasibility study and funding incentives and becoming a model for other districts. What is happening in other districts on this side of the state can impact our programs as the state sees the need to spread out the funds evenly, so we must stay on top of our best interests for our students and keep communicating with the state.

Suggestions from board to take a look into local agencies to help keep programs updated and help recruit students to new offerings. Acquiring input from local advisory boards etc. it would be helpful to give us ideas and strategize our directional needs.

Mr. Torrence shared the WVTSC Vocational Advisory Handbook, supporting the employment needs of the 21st century. It helps to illustrate what direction they are trending. They continued their discussion in ways they are reaching out into the community and to students:

- Interviews on the radio local Spanish radio included
- Speaking at schools
- Speaking at organizations and clubs
- Reaching out to other districts

- Auto Tech and Collision Repair program is very active
- Plumber Union active
- Local Training on site
- DigiPen program
