Numbers released by the National Board for Professional Teaching Standards show that Washington has the second-most new NBCTs (945), behind only North Carolina, and is fourth overall in the total number of NBCTs (6,242).

For each of the District's five funds, the budget status report shows the annual budget, the year-to-date revenues and expenditures, and the percent received/expended. The highlighted figure at the foot of each "Actual" column is the ending fund balance for that fund.

GENERAL FUND With **16.7**% of the fiscal year elapsed, Total General Fund revenues were **16.5**% and expenditures were **15.7**% of budgeted amounts.

SPI has changed the designations for fund balance categories.

At October 31, 2011, Ending Fund Balance is now designated as:

Operating Transfer of \$1,500,000 is budgeted for potential fund transfers for property or construction projects.

The district's M&O Levy for 2012 collection is \$10,492,000.

Brief discussion followed about bus depreciation schedule that changed this year at the state level. Mr. Vandervort explained that all the processes have slowed down at the state level and seem to take longer to get things through the channels.

2) **Enrollment Report:** CFO Les Vandervort presented the following enrollment report to the board.

Exhibit A - Monthly Enrollments.

The **December 2011** count of K-12 students is **7,726.70 full-time equivalents (FTE)** including 143.96 FTE Running Start students (Running Start students are counted starting in October).

The average FTE is **7,736.46** which are **47.96** FTE above budgeted average FTE of 7,689.

Exhibit B shows the changes in our average FTE enrollment, as reported to SPI, over time. Exhibit B reflects the history of our actual state funding level of FTE.

Exhibit C is a restatement of enrollment from 2000-01 for comparability.

Kindergarten is restated based on headcount rather than FTE due to the state funding formula changes. All day kindergarten at Columbia has been BEA funded since 2007-08. All day kindergarten at Lewis & Clark, Lincoln, and Mission View has been BEA funded since 2008-09.

The current Wenatchee Valley Technical Skills Center counts for grades 9-12 have been included in years prior to 09-10 for comparability.

Exhibit D shows the monthly information in graphic form, with a comparison to last year's enrollment and 2010-11 budgeted numbers.

Brief discussion followed about overloads at the kindergarten and 5th grade levels in two schools. Mr. Vandervort answered the board's questions. The board thanked Mr. Vandervort for the reports.

3) Valley Academy Purchase Agreement:

WSD Counsel, Phil Johnson explained to the board that this agreement has been discussed several times but he would be happy to go over highlights if they would like. It is not the actual purchase agreement but more like the "earnest agreement" and when the do-diligence process is completed we will actually purchase the property with a resolution and preliminary agreement.

The board wanted to know why we see it as a good idea to purchase this property. Mr. Vandervort told the board that it makes good financial sense to purchase the property. The lease payment after 5 years we have nothing, purchasing then we still own it after 5 years. Mr. Lovercamp, Valley Academy Director, said they have grown into the property and it has worked out really well for them.

The purchase price is listed at \$750,000 and has been assessed at \$1,500,00.

Discussion followed about section 4.3. Our protection in "hold harmless" is concerning the parking lot issue of encroachment on the neighbor's property. As follows:

- 4.3 <u>Buyer's Contingencies.</u> Buyer's obligation to purchase the Property is expressly contingent upon the following:
 - (a) <u>Feasibility Study</u>. Buyer's approval, prior to the expiration of the Feasibility Study Period, of the suitability of the Property as a result of the Feasibility Study;
 - (b) <u>Environmental Condition.</u> Buyer's approval, prior to expiration of the Feasibility Study Period, of the environmental condition of the Property pursuant to Section 8;
 - (c) <u>Title Policy</u>. Buyer's receipt of Title Company's firm commitment to issue upon closing the Title Policy as described in Section 3.3;
 - (d) Representations and Warranties. All of Seller's representations and warranties contained in or made pursuant to this Agreement being true and correct when made and as of the Closing Date;
 - (e) <u>Seller's Compliance</u>. Seller's timely performance of all of its obligations under this Agreement; provided, Seller will be given notice of any failure on its part to perform obligations pursuant to Seller's warranties made in Section 7.1 and those obligations required of it during the Feasibility Study Period, and will have a period of time that is reasonable under the circumstances to cure its nonperformance;
 - Survey. Buyer's review and approval, prior to expiration of the feasibility study period, of the survey described in Section 12; and
 - (g) Other Buyer's Approvals. Buyer's approval of the Due Diligence Materials prior to the expiration of the Feasibility Study Period.
 - (h) <u>Lawful Use</u>. Approval from the City of Wenatchee, prior to the expiration of the Feasibility Study Period, that the Buyer's intended uses of the Property will be lawful to the satisfaction of Buyer.
 - (i) <u>Sufficient Parking</u>.
 - (1) Buyer's review and approval, prior to the expiration of the Feasibility Study Period, that the number of parking spaces on the Property are sufficient for Buyer's intended use of the Property.
 - (2) Buyer obtaining final approval, prior to the expiration of the Feasibility Study Period, from the City of Wenatchee of its application for alternative parking analysis/transportation demand management in accordance with Wenatchee City Code 10.60.075.
 - Access to Property. Buyer's review and approval, prior to the expiration of the Feasibility Study Period, of the sufficiency and enforceability of lawful access to the Property.
 - (k) <u>State Requirements.</u> Satisfaction of requirements imposed on the School District by the State of Washington regarding the purchase of the Property.
 - Operating Systems. Buyer's approval, prior to the expiration of the Feasibility Study Period, of the condition of the plumbing, electrical, mechanical and heating, ventilation and air conditioning of the Property.
 - (m) <u>Corrections and Modifications by Seller</u>. Buyer's satisfaction and approval of the corrections and modifications to be made by Seller in accordance with Section 9 below.

The foregoing conditions contained in Sections 4.3(a) through 4.3(m) are collectively referred to in this Agreement as "Buyer's Contingencies."

4.4 <u>Satisfaction/Waiver of Buyer's Contingencies</u>. Buyer's Contingencies are solely for the benefit of Buyer. If any of Buyer's Contingencies are not timely satisfied, Buyer will have the right, at its sole election, either to waive any of them in writing and proceed with the purchase or to terminate this Agreement. If Buyer elects to terminate this Agreement, the escrow will be terminated, all documents and other funds will be returned to the party who deposited them, and neither party will have any further rights or obligations under this Agreement, except as otherwise provided in this Agreement.

Mr. Johnson informed the board that the new language protects the district. He asked for approval.
