- The student then puts the "You've Been Caught" award in a container by the principal's office & 10 of the forms are randomly selected each month...and those 10 students receives a special prize.

- Between 200 & 300 "You've Been Caught" Awards are presented to Lincoln students each month.

# Make Your Day (MYD)

- The entire Lincoln staff works hard to appropriately and consistently implement the Make Your Day citizenship program.
- We annually use teacher self-assessments and classroom observations to improve consistent school-wide implementation and more importantly, to ensure that the program is fair for students
- 100% of Lincoln teachers indicate that MYD encourages students to accept responsibility for their behavior.

### Make Your Day (MYD)

- 97% of Lincoln teachers indicate that MYD reduces classroom and building behavioral disruptions AND makes the building safe for students.
- 88% of Lincoln parents surveyed feel that MYD is appropriately and consistently applied at Lincoln.
- 90% of Lincoln parents feel that MYD helps their children accept responsibility for their own behavior.

# 1)WVC Foundation & WSD Exchange of Property Contract and Resolution:

WSD Legal Counsel, Phil Johnson, gave a refresher summary of the terms of the contract and resolution for the trade of property of the WSHS property and Eagles property and the financial commitment for WSD with WVC Foundation.

#### **RESOLUTION NO. 09-11**

WHEREAS, on February 22, 2011, the Board of Directors ("the Board") of Wenatchee School District No. 246 ("the School District") adopted Resolution No. 01-11, by which the School District decided to enter into an agreement with Wenatchee Valley College ("the College") and the Wenatchee Valley College Foundation ("the Foundation") for the transfer of real property in Wenatchee, Chelan County, Washington, on the following principal terms and conditions:

- School District Property. The School District would transfer to the College
  the buildings and surrounding land at 1521 Ninth Street, which is the current site of WestSide High
  School, and the adjoining house and surrounding land at 1605 Ninth Street ("the School District
  property"). The School District property consists of approximately 4.17 acres.
- 2. <u>College/Foundation Property.</u> The buildings and surrounding land at 1508 and 1510 Ninth Street, which are the current site of the College's Music and Arts Building, and which is formerly known as the Eagles property, ("College/Foundation property"), would be transferred to the School District. The College/Foundation property consists of approximately 8.04 acres.
- 3. Payment by School District. The market value of the College/Foundation property which would be transferred to the School District is \$2,922,000. The market value of the School District property which would be transferred to the College is \$1,095,000. In order to equalize the values of the properties, at closing, the School District would pay to the College/Foundation the sum of \$1,827,000, which is the difference in the market values of the College/Foundation property and the School District property.
- 4. Closing. The closing of the property transfers would occur after satisfaction of contingencies described in the Agreement, but no later than 120 days after the date of signing of the Agreement.
- Possession. After closing, both the School District and the College would lease the transferred properties to the other in accordance with leases to be signed at closing.
  - The College would have the continued possession of the College/Foundation property until completion of construction of its new Music and Arts Building.
  - The School District would have the continued possession of the School District property until completion of remodeling and relocation of WestSide High School to the College/Foundation property.

The exact dates of transfer of possession would be established by agreement of the School District and the College.

- 6. Right of First Refusal. At closing, the School District would grant to the College and the Foundation a first right of refusal to purchase back the College/Foundation property if the School District was to decide to sell the College/Foundation property within the next 25 years.
  - Use of the Properties.
    - The College will use the School District property for ordinary and necessary operations of the College.
    - The School District will use the College/Foundation property as the new site for WestSide High School.

WHEREAS, Resolution No. 01-11 provided, in relevant part, that the Superintendent is authorized and directed to prepare a final Agreement in accordance with Resolution 01-11 and then to present the Agreement to the Board at a later meeting for final review and signing.

WHEREAS, the Superintendent, through School District counsel, has prepared a final Agreement ("the Agreement"), which is hereby presented to the Board for final review and signing. RESOLUTION NO. 09-11 Page 2

WHEREAS, the Board deems it to be in the best interest of the School District to convey the School District property and to acquire the College/Foundation property in accordance with the Agreement.

### NOW, THEREFORE, BE IT RESOLVED by Wenatchee School District No. 246 that:

 The President of the Board, Kevin Gilbert, and the Board Secretary/ Superintendent, Brian L. Flones, are authorized and directed, on behalf of the School District, to execute the Agreement.



First, do you feel things in Washington State are generally going in the right direction or do you feel things have pretty seriously gotten off on the wrong track?




Voters are pessimistic. 56% say Washington State is on the wrong track.

The mood has deteriorated steadily since 2007.

Democrats are the only somewhat upbeat group (48% right direction/38% wrong track) but mood among Democrats has dropped 19 points since 2009.



GOP voters are very pessimistic (18% right direction/74% wrong track). Which of the following six issues do you believe is the most important for Washington state and local government to be working on?




Importance of education funding has increased (+11 pts).

Education funding is more important to Democrats (47%) and those children in school (41%).

Anti-tax sentiments are strong especially among GOP (49%) and those in rural areas (37%).

Do you agree or disagree – I just can't afford to pay additional property taxes, regardless of what they are used for?




Anti-tax sentiments remain high (46%), especially among GOP (58%) and rural voters (60%).

Democrats (61%) and Seattle (63%) residents are less concerned about taxes.

- · Voters remain pessimistic.
- Concerns about education funding are high but are counter-balanced with anti-tax sentiments.
- Divisive political environment impacting public opinion.

What grade would you give the schools in your local school district: A, B, C, D or Fail?




Grades for school district performance have rebounded from 2003-07 slump.

Voters age 18 to 34 years (65%), parents (64%), Eastern Washington voters (63%) and Democrats (62%) give highest grades.


Trend line for performance has improved steadily since 1991.

Thinking about education in general, in your opinion, what is the biggest problem facing schools in Washington State today?




Funding dominates as most important education issue. Concerns about discipline have declined since 1995 (- 12 pts). The importance of other issues are unchanged.

Grades for technology, discipline and financial management have improved over time but are generally unchanged during the past two years.

Do you favor or oppose a bond measure to fund:



Less than 60% of all voter subgroups favor new construction.


Would you vote for or against a bond measure to fund the purchase of technology for classrooms in your area?

Strongest support is among Democrats (80%), voters age 18 to 34 years (80%), A/B grades (76%), parents (74%) and Puget Sound voters (73%).


Would you vote for or against a bond measure to modernize existing school buildings in your area?



Support for remodeling schools returns to norm.

Strongest support is among Democrats (74%), voters age 18 to 34 years (73%), A/B grades (72%) and parents (72%).

Would you vote for or against a bond measure to construct new school buildings in your school district?




Less than half support for new construction bond.

Would you vote for or against a maintenance and operation levy for your local public schools?




More than 60% voters support an M&O Levy, well above the required 50% majority.

The change to a simple majority provides some breathing room.


Six in ten of all groups favor an M&O levy.

If your local school district decided to seek funding to support school operations with a maintenance and operation levy and to finance construction with a bond measure, would your rather have a:




Voters are more likely to prefer joint levy/bond elections, especially Democrats (58% joint). GOP and Independent voters are evenly divided.

The economy is impacting expectations and opinions.


- 70% agree local schools will need to reduce funding in some areas during the next few years.
- 55% agree they would not support a financing proposal for school construction, given the current economy.

- Campaigns don't end until the ballot boxes close.


- Support support for new school construction is anemic while the vital signs for technology and remodeling improved somewhat.

Non-district media are still the primary sources of information for voters about education issues.

Newspapers (33%) are the top source for information followed by school employees (10%).

Parents are most likely to use district sources, such as district/school newsletters, school employees, students, district website.

Non-parents are more likely to use non-district sources. During the past year, have you used the Internet to get any type of information about your local schools, education or school district?

- 88% have Internet access, unchanged since 2009.
  - More than 80% of all voters subgroups have internet access.
- 58% used the Internet to get information about local schools. (+ 5 pts)
  - Parents (82%) and voters age 18 to 54 years (65%) are more likely to use the Web for school information.

Dr. Newman also presented the "The Bumpy Road to Recovery" by Richard Davis – Washington Research Council. He hit highlights in that presentation. Areas of discussion:

- Make a big effort to reach all of community members

# 1) Enrollment Report: WSD CFO Les Vandervort reported the following

Exhibit A - Monthly Enrollments.

The **September 2011** count of K-12 students is **7,572.48 full-time equivalents (FTE)** including 0 FTE Running Start students (Running Start students are counted starting in October).

The average FTE is **7,572.48** which are **23.98** FTE above budgeted average FTE of 7,549 (prior to Running Start students being counted).

Exhibit B shows the changes in our average FTE enrollment, as reported to SPI, over time. Exhibit B reflects the history of our actual state funding level of FTE.

Exhibit C is a restatement of enrollment from 2000-01 for comparability.

Kindergarten is restated based on headcount rather than FTE due to the state funding formula changes. All day kindergarten at Columbia has been BEA funded since 2007-08. All day kindergarten at Lewis & Clark, Lincoln, and Mission View has been BEA funded since 2008-09.

The current Wenatchee Valley Technical Skills Center counts for grades 9-12 have been included in years prior to 09-10 for comparability.

Exhibit D shows the monthly information in graphic form, with a comparison to lastyear's enrollment and 2010-11 budgeted numbers.

Brief discussion followed about Running Start, BEA funding for kindergarten, all day vs half-day. The board thanked Mr. Vandervort for the report.
